



Jobsite COVID-19 Symptom Screening

While more people are getting back to work, companies are taking precautions necessary to keep their employees safe. One way companies are choosing to obtain this is by having employees/visitors answer a series of screening questions about their recent health and activities.

Applied Data Consultants developed a questionnaire to be administered on an app - powered by jotform.com - a form building website fully customizable to add logos, questions and information desired by any given company. Answers and information can be set to automatically fail the form and not allow the employee to begin working. For instance, if the answer to question 1a below was "Yes" a message will appear:

Based on your response, you are temporarily denied entry to this office, warehouse, or project site. Please depart the premises immediately. We welcome you back once you are symptom-free.

Each company will be supplied with a unique QR code to post at their jobsite. Using their personal mobile devices, employees/visitors will simply scan the QR code with their camera or enter the url in their web browser sending them directly to the form. A sample QR code can be found on page 3.

Pricing: \$150 one time setup fee

Companies with 1-5 locations: \$50 / year

Companies with 6-15 locations: \$75 / year

Companies with 15+ locations: \$100 / year



A step by step “How to” page will also be supplied to post near the QR code for the employees to follow. (Example supplied)

Once the form has been completed and signed, the employee will press submit and the information will be integrated and saved into a spreadsheet, visible by those with such permissions. Email notifications can be sent out to those monitoring the forms. Information in the notification includes the employee’s name, date and time the form was completed. If the employee chooses, they can enter an email at the bottom of the form to receive a copy of their completed questionnaire. The email the employee will receive will have the following information:


